

Graduate School Scholarship for International Students

[2021. 06. 01.]

International students are accepted to the graduate school through two admission tracks, and the types of graduate scholarships available are different depending on the track. Be advised to check your admission track for the relevant scholarships.

※ How to check your admission track

1. **General Admission**: Students who enter the general admission track (**within the quota**)
(Students who entered Spring Semester 2021)
2. **Special Admission**: Students who enter the special admission track (**beyond the quota** for international students)
(Students who entered before Fall Semester 2020 and will enter Fall Semester 2021)

Graduate school scholarships differ according to the admission track.

Internal university scholarships are granted to students accepted to the General Admission track. However, the students accepted to the Special Admission are eligible for internal university scholarships or the Global Korea Scholarship which is granted by the Korean Government.

1. General Admission (**within the quota**)

(1) Internal University Scholarship

- Type-A scholarship (100% tuition) is provided to full-time graduate school students who assist professor's educational and research activities.
(✂It may change depending on the scholarship budget of each year)
- Scholarship Payment Period:
 - Spring Semester: May
 - Fall Semester: November*(✂Payment through wire transfer to the student's personal account)*
- Selection Criteria:
 - Enrolled students: with a GPA of 3.5 or higher in their previous semester
 - All students who will begin their first semester
- Up to 4 semesters per degree (8 semesters for the integrated Master's and Doctoral program)

2. Special Admission for International Students (**beyond the quota**)

(1) Internal University Scholarship

- Type-B scholarship (50% tuition) is provided to those who meet the Type-B qualifications.
- Payment Period: At the time of tuition payment, 50% of tuition is exempted.
✂ Type-A scholarships can be provided as the scholarship budget allows (an additional exemption by 50% of remaining tuition)
 - Target: students who entered after Spring Semester 2020
 - Wire transfer to the student's personal account in May (Spring Semester) & November (Fall Semester)
- Selection Criteria:
 - 1st Semester Students: Language scores at the time of admission
 - Enrolled Students
 - Students who entered before 2019: Language scores at the time of admission & GPA 3.5 or higher in their previous semester

- Students who entered after 2020: Language scores at the time of admission or during the enrolled period & GPA 3.5 or higher in their previous semester
- ※ The language score requirements by year of enrollment are as follows:

- Up to 4 semesters per degree (8 semesters for the integrated Master's and Doctoral program)

(2) GKS (Global Korea Scholarship)

- Students selected by NIIED (National Institute for International Education) of the Ministry of Education
- Full tuition exemption (funded by Korean Government)
